## Focus Group Five

### 1500 – 1800 **Cross-border negotiations of a joint venture**

Drafting and negotiating a joint venture (especially cross-border transactions) has complex legal, commercial and even cultural intricacies. The aim of this workshop is to experience these intricacies by simulating a fact situation. The attendees and the expert panellists (drawn from diverse cultural and legal backgrounds) will be divided into groups to consider issues on behalf of parties to a Joint Venture agreement.
